Frederick Wimhurst, 1858-1932, a native of Lewes, Sussex, England, was married in 1894 to Anna Moser, 1868-1955, daughter of a pioneer Galveston family. In 1882 Wimhurst established the paint firm that became known as Wimhurst Brothers when it was taken over by his sons George A. and Fred Jr. in 1915. In the 1920's the business, grew from a supply house into a contracting firm, and by the 1950's included real estate. It continued until the death of Fred Jr. in 1962.

Papers include correspondence, receipts, marriage and death notices, wills, income tax returns, insurance policies, bank statements, stock certificates, deeds, contracts, leases, and business record books.
