These records concern the decision of the Board of Trustees of the Galveston Wharves to relocate the "mosquito fleet" (shrimp and party boats) from Pier 19 to Pelican Island in order to improve facilities of Pier 19 to accommodate ocean going vessels. Records also cover the efforts of the Pier 19 tenants to confront the Board decision by forming a committee of interested persons.

These papers were donated by Ralph Woods, a leading member of the committee to save Pier 19. Records include correspondence, notes, minutes, copies of city ordinances and clippings and drawings relating to the campaign to save Pier 19 for the mosquito fleet.
