H. W. Darst collected the letters of Robert Hodges, Jr. who was the older brother to Susan Hodges Darst (grandmother to H. W. Darst). Robert Hodges, Jr. left his family in Fort Bend County to serve the Confederacy in the Civil War. The letters contain opinions of officers, skirmishes, sickness, and prices of provisions. He also writes about seeing a female Lieutenant, thought to be Amy Clarke a.k.a. Richard Anderson.

The second part of the collection is research material done by H. W. Darst's son, William Maury Darst. He collected information about Robert Hodges, Jr., including his Civil War military record and request for a Confederate pension. A few of the Civil War letters have been transcribed by hand.
